Motion Rood/Teall to approve Collins Land Services bid in the amount of \$4,400 to move the shed to the township property located at 3088 N. Clare Ave. All ayes, motion carried.

After discussion on the two (2) road projects submitted by Supervisor Jones, he recommended the Ridge Road project be done this year and did not recommend the Mostetler Road project at this time.

Motion Hoyt/Rood to approve Clare County Road Commission contract for Ridge Road project not to exceed \$37,135.07 to be paid from Road Fund. All ayes, motion carried.
