Roll call vote: Jones-aye, Buckley-aye, Teall-aye, Rood-aye, Hoyt-aye. Motion carried.


Motion Rood/Teall to authorize Supervisor Jones to contact the township attorney regarding Dangerous Building Ordinance. All ayes, motion carried
